



Millbrook First Nation to be the economic engine for the benefit of its members.




POSITION RESPONSIBILITIES

Knowledge Of:

- Lobster pound infrastructure, associated equipment and technical specifications of water quality filtration and monitoring systems.
- Lobster handling and quality best practices.
- Traceability, eco-certifications (e.g. Marine Stewardship Council) and other sustainability programs.
- Provincial buying and processing regulations and federal export protocols.
- Canadian Food Inspection Agency and HACCP plans.
- Federal, provincial, NGO, academic and First Nation partnership funding streams.
- Cultural sensitivity towards First Nations culture and our way of life.
- Knowledge of Mi'kmaw culture and general issues of the Millbrook First Nation community.

Key Skills:

- Proficiency in leadership and team development.
- Adaptability to evolving challenges and opportunities
- Proficiency in using computers and software applications.
- Excellent interpersonal skills.
- Ability to function within a team.
- Strong decision-making and problem-solving skills.
- Effective written, and verbal communication, and active listening skills.

Abilities:

Plan, direct, and manage all daily operations that would include:

- Communication with harvesters supplying product.
- Overseeing the purchase of raw materials in coordination with the Sheet Harbour Wharf and Property Supervisor.
- Maintain records to standards required by provincial and federal licensing bodies.
- Coordinate planned activities related to the management of holding facility including but not limited to, meetings with federal and provincial government representatives, other Indigenous communities, and other industry interest holders.
- Create and maintain positive, effective client relationships— Responsible for customer satisfaction and supporting dispute resolution as required.
- Keep up to date on market conditions, trends and political dynamics that may affect the business.
- Set production goals and ensure that these goals are being met or exceeded.
- Conduct daily administrative and strategic planning tasks including but not limited to the development of employee work schedules, equipment and supply orders, maintenance logs, and repair costs.
- Stay up to date on community-authorized harvesting plans, government regulation and policies, and create and implement new holding facility policy directives as required (in coordination with the Business Development Manager).

EXPERIENCE & EDUCATION

- Relevant post-secondary education.
- At least three years' experience working directly with Indigenous Organizations and/or First Nation communities.
- Experience working in the seafood or fishing sectors in a management or supervisory capacity is an asset.
- Experience working in a lobster holding facility in any capacity is considered an asset.
- St. John's Ambulance/First Aid Certificate would be an asset.
- Lobster Quality and Handling Course will be required.
- Criminal Record Check (If applicable).
